Applicants

Entry requirements

- Master's degree, preferably MBA or equivalent master/ diploma (pre-Bologna structure) from officially recognised and accredited higher education institutions (university or university of applied sciences)
- Admission and enrollment in the doctoral program is decided by the academic management at SMBS
- Applications must be in written form, e-mail or post, with a complete application folder and submission of all required documents such as:
 - CV
 - diplomas and certificates of previous studies
 - letter of motivation

Academic Degree

Our program offers you the unique opportunity to pursue an in service postgraduate course @SMBS and subsequently apply for a Ph.D. program at one of our renowned partner universities.
